This applies also to applicants who have passed Part 1 but are not licensed in any state. **Individuals whose initial applications for EPPP only, Exam & Licensure or Waiver (passed Part 1 but not yet licensed) that were received prior to November 1, 2020 must pass only Part 1 to qualify for licensure.***
