**4. DISCUSSION REGARDING APPROVAL OF PSYCHOLOGY APPLICANTS**

*Per the Board's decision on July 9, 2020, individuals who submit the initial application for EPPP only, Exam & Licensure on or after November 1, 2020 must pass EPPP Part 1 – Knowledge (Part 1) and EPPP Part 2 – Skills (Part 2) to qualify for licensure. This applies also to applicants who have passed Part 1 but are not licensed in any state. Individuals whose initial applications for EPPP only, Exam & Licensure or Waiver (passed Part 1 but not yet licensed) that were received prior to November 1, 2020 must pass only Part 1 to qualify for licensure.*
