1. CALL TO ORDER

The regular session of the Arizona Board of Psychologist Examiners Complaint Screening Committee was called to order by Chairman Shreeve, at 9:01 a.m. on April 6, 2016.

3. APPROVAL OF MINUTES

- a. Dr. Beljan made a motion, seconded by Dr. Flowers, to approve the March 9, 2016, Regular Session meeting minutes as drafted. Motion carried (3-0), by a voice vote.
- b. Dr. Flowers made a motion, seconded by Ms. Shreeve, to approve the March 9, 2016, Executive Session meeting minutes as drafted. Motion carried (2-0-1), by a voice vote, with Dr. Beljan abstaining.

4. CASE DISCUSSION/DECISION

a. Julia Lesselyong, Psy.D., RFI 16-04

Dr. Beljan summarized the case, including salient points of the investigation and pertinent records. The Complainant was not present. The Licensee and her attorney, Charles Hover, were present and answered Committee member questions. After deliberation, Dr. Beljan made a motion, seconded by Dr. Flowers, to forward this case to the full Board for possible violations of A.R.S. §32-2061(15)(e), for possible gross negligence in the practice of a psychologist; and A.R.S. §32-2061(15)(cc), for possibly failing to make available to a client or patient or to the client's or patient's designated representative, on written request, a copy of the client's or patient's record, including raw test data, psychometric testing materials and other information as provided by law. The motion carried unanimously (3-0), by a voice vote.

b. Kyle Lininger, M.P.A., RFI BA-16-01

Ms. Shreeve summarized the case, including salient points of the investigation and pertinent records. The Complainants, N.N. and A.K., were present telephonically and N.N. made a statement. N.N. and A.K. answered Committee member questions. The Licensee and his attorney, Courtney Henson, were present and Ms. Henson made a statement. The Licensee and Ms. Henson answered Committee member questions. After deliberation, Dr. Beljan made a motion, seconded by Dr. Flowers, to dismiss the complaint upon finding no violation of statute or rule. The motion carried unanimously (3-0), by a voice vote.

5. ADJOURN

There being no further business to come before the Committee, Dr. Flowers made a motion, seconded by Dr. Beljan, to adjourn the meeting. The motion carried (3-0) and the meeting was adjourned at 10:45 a.m.
