After deliberation, Mr. Robichaud made a motion, seconded by Dr. Mellott, to forward this case to the full Board for possible violations of A.R.S. § 32-2084(C)(1), for possible use of the designation "psychology", "psychological" or "psychologist" by a person not licensed pursuant to Chapter 32, Title 19 of the Arizona Revised Statutes; and A.R.S. § 32-2084(C)(2), for possible use of any combination of words, initials and symbols that leads the public to believe the person is licensed to practice psychology in this state, by a person not licensed pursuant to Chapter 32, Title 19 of the Arizona Revised Statutes. The motion carried unanimously (3-0), by a voice vote.
