3.	DISCUSSION, CONSIDERATION AND POSSIBLE ACTION ON PSYCHOLOGY APPLICATIONS		
	<p><i>As of November 1, 2020, the EPPP consists of two parts: Part 1 - Knowledge and Part 2 - Skills. A passing score on both parts of the EPPP are required to qualify for an independent and unrestricted license in Arizona. Individuals whose applications for the supervised Temporary License w/ and w/out EPPP, EPPP only or Exam & Licensure were received prior to November 1, 2020 must pass only Part 1 to qualify for licensure.</i></p> <p><i>Individuals who submit an application on or after November 1, 2020 in the following categories must pass both parts of the EPPP to qualify for licensure: EPPP Only, EPPP & Licensure, and the supervised Temporary License w/ and w/out EPPP. This also applies to applicants who have passed Part 1 but are <u>not</u> independently licensed in any state.</i></p> <p><i>Individuals submitting a reapplication on or after November 1, 2020, are required to pass both Part 1 and Part 2 of the EPPP in order to qualify for licensure, regardless of when their initial application was received.</i></p>
