Stuart Goodman from Goodman Schwartz Public Affairs was present telephonically and provided an update to the Board. Mr. Goodman stated that it does not appear that the Arizona Medical Board will move forward with legislation regarding its licensure compact; however, this position may change. Mr. Goodman recommended that the Board continue to maintain its placeholder and run legislation for the Psychology Interjurisdictional Compact, if the physicians run compact legislation. Following deliberation, Mr. Donaldson made a motion, seconded by Dr. Brundage, to accept Mr. Goodman's recommendation to proceed forward with legislation if the physicians move forward with legislation. The motion carried 8-0.
