# 3. DISCUSSION, CONSIDERATION, AND POSSIBLE ACTION PERTAINING TO AREAS OF CONCERN IDENTIFIED IN THE DRAFT RULES PRIOR TO SUBMITTING RULES TO THE SECRETARY OF STATE FOR PUBLICATION INCLUDING DISCUSSION OF RESULTS FROM PILOT SURVEY SENT TO CLINICAL TRAINING DIRECTORS

Dr. Olvey provided a summary stating that there are several items of the draft rules that may need to be corrected/addressed. The Committee discussed the following items:

- Consistency of the use of the term "client and/or patient"
- Residential addresses should be included in rule
- Question pertaining to active military status included in the licensure application
- Question in the application for licensure regarding criminal history
- Use of proper terminology regarding the American Psychological Association and accreditation of programs and internships
- Adding the word "reference" as relevant
- Applicant is required to satisfy core program requirements
- The Board does not need an applicant's consent to request additional information for an application

- Verification for preinternship experience hours and written training plan by the degree-granting institution
- Addition of questions to the application for licensure by credential to be consistent with the questions on the application for licensure
- Applicants applying to sit for the Examination for Professional Practice in Psychology only and whether they be required to answer questions regarding criminal history and be required to submit a self-query
- Reapplication and the documents required
- Limit the number of years of employment history reported by applicants to 10 years
- No changes to extension requests to sit for the Examination for Professional Practice in Psychology
- Preapproval of study plans in regards to a reapplication
- Involuntary separation or discipline by the military
- Reporting Exam scores to applicants in a timely manner
- Renewal questions and untimely renewal of license
- Reactivation of inactive license and documentation required
- Continuing education requirements decreased to 40 hours and eliminate category II
- Remove the section pertaining to additional examinations
- Supervision and substantial financial interest
- Postdoctoral experience and the required direct client contact hours (40%)
