<u>Asheeki Elmore, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Elmore's application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Elmore's application to the full Board for approval to take the EPPP.

#### **Requesting Approval to sit for Examination (EPPP) & Licensure**

<u>Bekayla Dewar, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Dewar's reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Dewar's reapplication to the full Board for approval to take the EPPP and licensure upon a passing score and payment of the prorated license fee.

<u>Comel Belin, Ph.D.</u> – Committee members proceeded with a substantive review of Dr. Belin's reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Belin's reapplication to the full Board for approval to take the EPPP and licensure upon a passing score and payment of the prorated license fee.

<u>Emily Huls, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Huls' application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Huls' application to the full Board for approval to take the EPPP and licensure upon a passing score and payment of the prorated license fee.

Jodi Cuneo, Ph.D. - Committee members proceeded with a substantive review of Dr. Cuneo's application. Upon review of her Supervised Preinternship Experience Verification form from Counseling and Consulting Services, the Committee noted that her Field Placement Coordinator, Rodney Ford, Ph.D., indicated that Dr. Cuneo obtained 864 experience hours. His subsequent calculations indicated that Dr. Cuneo received 22 total hours of individual supervision which does not meet the requirement of A.R.S. §32-2071(E)(4)(c). At this time Dr. Cuneo is 21.2 hours deficient in meeting the individual supervision requirement. The Committee is requesting clarification as to the number of individual supervision hours she received. The Committee noted that it can apply 2,143 hours in internship. At this time Dr. Cuneo remains 857 hours deficient in meeting the 3,000 hours supervised work experience requirement (A.R.S. §32-2071(D)). The Committee noted that she may wish to submit postdoctoral experience to meet the 3,000 supervised work experience requirement. Additionally, the Committee noted that the "Internship Training Manual" was submitted for her written training plan which does not meet the requirement of A.R.S. §32-2071(E)(2)(5) and R4-26-210(A)(3). If she wishes to apply her preinternship experience toward licensure, the Committee is requesting that her written training plan be submitted for her experience at Counseling and Consulting Services. The Committee voted to recommend that Dr. Cuneo be approved to sit for the EPPP while she completes additional supervised experience hours.

<u>Keith Reinhardt, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Reinhardt's application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Reinhardt's application to the full Board for approval to take the EPPP and licensure upon a passing score and payment of the prorated license fee.

<u>Kelly Rodriguez, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Rodriguez's application and subsequent submission. Upon review of her Supervised Preinternship Experience Verification form from Southwest Behavioral Health Services, the Committee noted that her Director of Clinical Training, Eric Johnson, Psy.D., indicated that Dr. Rodriguez obtained 806.5 total hours. His subsequent calculations indicate that Dr. Rodriguez obtained 35.5 hours of individual supervision which does not meet the requirement of A.R.S. §32-2071(E)(4)(d). At this time Dr. Rodriguez is 46 hours deficient in meeting the individual supervision requirement. The Committee can apply 333 of her preinternship hours at Buwalda Psychological Services and 2,002 of her internship hours at Buwalda Psychological Services for a total of 2,335 hours. At this time Dr. Rodriguez remains 665 hours deficient in meeting the 3,000 hour supervised work experience requirement. The Committee noted that she may wish to submit postdoctoral experience to meet the 3,000 hour supervised work experience requirement.

<u>Kristin Schwartz, Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Schwartz's application and subsequent submission. Upon review of her Supervised Preinternship Experience Verification form from the Rockies Counseling Center and her cover letter, the Committee noted that she is applying 964 hours that meets the requirement of A.R.S. §32-2071(E). The Committee noted that it can apply 964 preinternship hours and 2,006 internship hours toward the 3,000 hour requirement. At this time she remains 30 hours deficient in meeting the 3,000 hours supervised work experience requirement (A.R.S. §32-2071(D)). The Committee noted that she may wish to submit postdoctoral experience to meet the 3,000 supervised work experience requirement.

<u>Michele Ishikawa, Ph.D.</u> – Committee members proceeded with a substantive review of Dr. Ishikawa's application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Ishikawa's application to the full Board for approval to take the EPPP and licensure upon a passing score and payment of the prorated license fee.

At this time Dr. Platt remains 921 hours deficient in meeting the 3,000 hours supervised work experience requirement (A.R.S. §32-2071(D)). The Committee noted that she may wish to submit her preinternship experience to meet the 3,000 supervised work experience requirement.

<u>Steven Caruso, Ph.D.</u> – Committee members proceeded with a substantive review of Dr. Caruso's reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to move Dr. Caruso's reapplication to the full Board for review and approval of licensure upon receipt of the pro-rated licensure fee.
