10 The Arizona Board of Psychologist Examiners (“Board”) received a request from Thomas
11 McCaffrey (“Respondent”), to be released from the terms and conditions of the above-referenced
12 Consent Agreement.

13 At its February 10, 2023 virtual meeting, the Board discussed and considered
14 requirements for release from the terms and conditions of the Consent Agreement. Respondent
15 appeared personally; accompanying him was Mr. Thomas Mack, his New Mexico-licensed
16 attorney but who did not appear on behalf of Respondent. The Board determined Respondent
17 substantially complied with all of the terms and conditions of the Consent Agreement.

18 **ORDER**

19 IT IS THEREFORE ORDERED that Respondent is hereby released from the terms and
20 conditions of the Consent Agreement (November 17, 2020). Respondent’s license is now
21 expired, as he elected not to renew his psychologist license by the January 31, 2023 expiration
22 date.
