3. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION ON PSYCHOLOGY APPLICATIONS

From November 1, 2020 to February 10, 2023, the Board was an early adopter of Part 2-Skills of the Examination for Professional Practice in Psychology (EPPP); new applicants were required to take and pass Part 2 to qualify for licensure in Arizona. On February 10, 2023, the Board determined to suspend Arizona's participation as an early adopter jurisdiction, effective immediately. Therefore, as of February 10, 2023, approved applicants who submitted applications in category A of this agenda may meet the statutory requirements in A.R.S. § 32-2072 with a passing score on Part 1-Knowledge of the EPPP.
