9 The Arizona Board of Psychologist Examiners (“Board”) received a request from Dana
10 Johnson (“Respondent”), to be released from the terms and conditions of the above-referenced
11 Consent Agreement.

12 At its February 9, 2024 public meeting, the Board discussed and considered
13 requirements for release from the terms and conditions of the Order. Respondent and her
14 attorney appeared virtually and addressed the Board. The Board determined Respondent
15 substantially complied with all of the terms and conditions of the Consent Agreement.

16 **ORDER**

17 IT IS THEREFORE ORDERED that Respondent is hereby released from the terms and
18 conditions of the Consent Agreement (effective October 11, 2023), including the term of
19 probation. As Respondent did not renew her license upon its expiration on October 31, 2023,
20 and because there is another pending complaint (no. 24-12) of which she was notified prior to
21 the expiration, her license remains suspended pursuant to A.R.S. §32-3202.
