**ORDER AMENDING CONSENT
AGREEMENT AND
ORDER FOR LICENSURE WITH
PRACTICE RESTRICTION AND
PROBATION**

10 On November 6, 2023, the Arizona Board of Psychologist Examiners (“Board”) and Ann
11 Eberhardt, Psy.D., (“Respondent”) entered into a Consent Agreement and Order for Licensure with
12 Practice Restriction and Probation. Pursuant to that Consent Agreement, Respondent’s application
13 for licensure was issued upon her securing a Board-approved Practice Supervisor. On February
14 13, 2024, Respondent submitted the name of a proposed Practice Supervisor and the Practice
15 Supervisor was approved by the Board’s Executive Director.

16 On September 6, 2024, Respondent appeared before the Board seeking approval of a new
17 Practice Supervisor due to the illness of her first Practice Supervisor. Additionally, Respondent
18 sought to amend Finding of Fact No. 6 of the Consent Agreement and Order because of an
19 inaccuracy.

20 **GOOD CAUSE APPEARING, IT IS THEREFORE ORDERED THAT:**

21 1. George Goldman, Ph.D. (PSY-003317) is approved as Respondent’s Practice
22 Supervisor. Dr. Goldman’s plan reflects a portion of the supervision is to be provided remotely as
23 approved by the Board.

24 2. Finding of Fact No. 6 of the November 2023, Consent Agreement and Order is
25 amended to Read:

26 “In 2019, Applicant/Respondent reapplied to the AzBBHE for licensure as a Licensed
27 Associate Counselor. AzBBHE approved the application under a 24-month stayed

1 suspension and under probation and with restrictions that are set forth in more detail in the
2 Board's files. Respondent/Applicant's license was later suspended after she failed to
3 comply with the terms of probation, but was eventually restored to active status with
restrictions.

4 3. All other terms and conditions of the November 2023, Consent Agreement and
5 Order remain the same to the extent they are consistent with this Order.
