Application Review Committee Virtual Meeting Minutes

December 6, 2024
Held via Zoom

1. CALL TO ORDER

The meeting was called to order by Committee Chair Dr. Flint at 7:31 a.m.

3. APPROVAL OF MINUTES

MOTION: Dr. Sideman moved to approve the minutes. Dr. Flint seconded.

VOICE VOTE: The motion carried unanimously.

4. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION ON PSYCHOLOGY APPLICATIONS

A. Requesting Approval to Sit for the EPPP (A.R.S. §§ 32-2071, 2071.01 & 2072)

- 1) Marissa Mascorro, Psy.D.

Dr. Flint recused from reviewing this application. Due to lack of a quorum, it was forwarded to the Board for substantive review.

- 2) Diana Galloway, Psy.D. (REAPP)

This application was erroneously placed in the EPPP Only category. However, it is an Exam & Licensure application.

Dr. Galloway was present at the meeting. Committee members proceeded with a substantive review of the reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the

requirements of the statutes and rules. It was the consensus of the Committee to forward the reapplication to the Board for approval to sit for the EPPP and licensure upon a passing score.

3) Sharon Simington, Psy.D. (REAPP)

Committee members proceeded with a substantive review of the reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of the statutes and rules. It was the consensus of the Committee to forward the reapplication to the Board for approval to sit for the EPPP.

It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score.

8) Jiayi Yu, Psy.D.

Dr. Yu was present at the meeting. Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of the statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score.

9) Caitlyn Albano, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of the statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score.

10) Sania Khan, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted two concerns:

- a) The preinternship verification submitted by Dr. Genevieve Arnaut, Director of Clinical Training for the practicum at Veterans Affairs Palo Alto Health Care System from 06/19/2021 to 06/17/2022 verified 1038.5 total overall hours with only 153 total direct client contact hours, which does not meet the requirements under A.R.S. § 32-2071(E)(4)(b).
- b) On the completed reference form from Dr. Christopher Adamczyk indicated that Dr. Khan worked only 25% in the field of psychology while under his supervision. The Committee believed this was likely a misunderstanding of the question.

It was the consensus of the Committee to issue a FAIR for clarification and/or correction and documentation relative to the above noted concerns.

11) Sonia Maus, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that on the preinternship verification submitted by Dr. Samara Way, Dr. Maus' school psychology doctoral program's Director of Clinical Training, Dr. Way's answer to question number 10 in Section D indicated 31% of the supervision was provided by a licensed psychologist and 69% of the supervision was provided by another type of licensed mental health professional which is inconsistent with A.R.S. § 32-2071(E)(4)(d). It was the consensus of the Committee to issue a FAIR for clarification and/or correction and documentation relative to the above noted concern.

12) Hannah Levy, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of the statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score.

MOTION: Dr. Flint moved to forward the applications of Drs. Melanie Estrada, Chelsey Maxson, Jonathan Shasteen, Estrella Ochoa, Venessa Martinez-Morales, Tehra Storms, Marca McCallie, Jiayi Yu, Caitlyn Albano and Hannah Levy to the Board for approval to sit for the EPPP and licensure upon a passing score and to issue FAIRs as noted above to Drs Sania Khan and Sonia Maus. Dr. Sideman seconded.

E. Requesting Approval for Licensure by Waiver (A.R.S. §§ 32-2071, 2071.01 & 2072)

1) Stihlyn Chamberlain-Scott, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the Thriving Minds Employment Agreement submitted as the written training plan (“WTP”) for Dr. Chamberlain-Scott’s postdoctoral supervised professional experience (“SPE”) states under subsection H:

“Compensation....the Employee shall be entitled to forty percent (40%) of gross revenue for regular client appointments....Employee will also be entitled to five hundred dollars (\$500) a year as a training stipend, which must be used by the end of the calendar year. Additionally, the employee will not be compensated for on-boarding or “training” (defined as any time spent observing psychological sessions or in orientation for the first two days of employment), staff meetings, case consultations, or peer supervision.”

The Committee noted that the compensation plan outlined in the WTP does not meet Arizona’s requirements in Rule, A.A.C. R4-26-209(C). It was the consensus of the Committee to issue a FAIR for clarification and documentation regarding the above.

2) Robert Connolly, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of the statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval for licensure.

3) Jennifer Kendall, Psy.D.
