13 for release from the terms and conditions of the Consent Agreement. Respondent was present  
14 and addressed the Board. Respondent’s practice monitor, Kimberly Becker, was also present and  
15 addressed the Board. The Board determined Respondent substantially complied with all of the  
16 terms and conditions of the Consent Agreement.

17 **ORDER**

18 IT IS THEREFORE ORDERED that Respondent is hereby released from the terms and  
19 conditions of the Consent Agreement (dated October 11, 2023), and his license is fully restored  
20 to active and unrestricted status this date.
