Upon a vote of a majority of the quorum, the Committee may go into Executive Session on any item on the agenda, pursuant to A.R.S. § 38-431.03(A)(3), to receive confidential legal advice from the Board's attorney, and/or A.R.S. §38-431.03(A)(2), to discuss confidential records and testimony.
