**ORDER DENYING REQUEST FOR
REHEARING OR REVIEW**

On May 20, 2025, the Arizona Board of Psychologist Examiners met in open session to consider Dr. Nicole Huggins' ("Respondent") Motion for Rehearing of the Board's Findings of Fact, Conclusions of Law and Order for Revocation dated August 5, 2024. The Board's consideration included Respondent's First Notice of Supplement to the Record on Review and related pleadings. The Respondent was present and represented by attorneys Paige Kemper and Andrew Turk. The State was represented by Jeanne Galvin, Assistant Attorney General. Carrie Smith, Assistant Attorney General, was present and provided independent legal advice to the Board. After full consideration of the record in this matter and the arguments of the parties, the Board voted to DENY Respondent's motion to supplement the record, and Motion for Rehearing for the reasons stated on the record. Respondent has set forth no grounds upon which a rehearing should be granted.

ORDER

Respondent's Motion for Rehearing is DENIED. The Board's Order dated August 5, 2024 shall become effective five (5) days after this Order is mailed.
