A person or a representative of a person who has filed or received a complaint and who is present at a Committee meeting may address the Committee by filling out a “Request to Speak Form” and giving it to a Board staff person. If you have submitted a Request to Speak form you will be given time to make a brief presentation to the Committee. In addition, the Committee may ask questions regarding a complaint. The Complaint Screening Committee Chair reserves the right to change the order of items on the agenda.

Upon a vote of a majority of the quorum, the Committee may go into Executive Session on any item on the agenda, pursuant to A.R.S. § 38-431.03(A)(3), to receive confidential legal advice from the Board’s attorney, and/or A.R.S. §38-431.03(A)(2), to discuss confidential records and testimony.
