4. DISCUSSION REGARDING APPROVAL OF PSYCHOLOGY APPLICANTS

A. Requesting Approval to Sit for Examination (EPPP) Only

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP.

2) Brian Arizmendi, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP.

3) Jessica Lynne Spigner, Ph.D.

Committee members proceeded with a substantive review of the application. B. Requesting Approval to Sit for Examination (EPPP) & Licensure

1) Christopher Robert Glowacki, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score and payment of the pro-rated license fee.

2) Elizabeth A. Johnson-Heston, Psy.D.

Committee members proceeded with a substantive review of the reapplication. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the reapplication to the Board for approval to sit for the EPPP and licensure upon a passing score and payment of the pro-rated license fee.

3) Ernesto Reza, Psy.D.

Committee members proceeded with a substantive review of the application and additional materials. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. However, the Committee expressed concern that Dr. Reza's additional information did not satisfy the Committee's concern regarding his use of the title "psychologist". It was the consensus of the Committee to forward the application to the Board for review of his use of the title "psychologist" and to request Dr. Reza's presence at the meeting.

4) Jeffrey L. Tinius, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the applicant's doctoral program in General Psychology from Capella University does not meet the requirements of A.R.S. §32-2071(A), and it did not include a clinical practicum or a clinical internship. It was the consensus of the Committee to forward the application to the Board with a recommendation for denial.

5) Laura E. Jimenez Arista, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score and payment of the pro-rated license fee.

6) Nicole M. Farmer, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score and payment of the pro-rated license fee.

7) Rosalba Mada, Ph.D.

Committee members proceeded with a substantive review of the application and additional information. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval to sit for the EPPP and licensure upon a passing score and payment of the pro-rated license fee.

C. Requesting Approval for Licensure by Waiver

1) David Michael Stein, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval of licensure upon payment of the pro-rated license fee.

2) Dixie Jean Woolston, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled

the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval of licensure upon payment of the pro-rated license fee.

3) Elizabeth Bacon, Ph.D.

Dr. Bacon was present on the teleconference call. Committee members proceeded with a substantive review of the application and additional information. Upon review, the Committee expressed concern that the applicant's Psychology doctoral program was not in an applied psychology and did not require a clinical practicum which does not meet the requirements of A.R.S. §32-2071. In addition, the Committee noted that her course work in Ethics and Assessment does not meet the requirements of A.R.S. §32-2071(A). The Committee answered Dr. Bacon's questions. It was the consensus of the Committee to forward the application to the Board with recommendation of denial.

4) Jessica Ostendorf Pishney, Psy.D.

Committee members proceeded with a substantive review of the application and additional materials. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval for licensure upon payment of the pro-rated license fee.

5) Jessica Weeks, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that Dr. Weeks was 49 hours deficient in individual face to face supervision for her postdoctoral experience which does not meet the requirement of A.R.S. §32-2071(G). It was the consensus of the Committee to request that Dr. Weeks have additional supervision hours submitted.

6) Lucinda Gray, Ph.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the Dr. Gray's doctoral program was not APA accredited at the time of her graduation. It was the consensus of the Committee to request that she complete the Core Program Requirements section of the application.

7) Margot Scott Bradley, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval of licensure upon payment of the pro-rated license fee.

8) Nicole C. Spanakis, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that the materials submitted were complete and fulfilled the requirements of statutes and rules. It was the consensus of the Committee to forward the application to the Board for approval of licensure upon payment of the pro-rated license fee.

9) Traci Ryan Spriggs Moreno, Psy.D.

Committee members proceeded with a substantive review of the application. Upon review, the Committee noted that Dr. Moreno's internship supervisor indicated that Dr. Moreno's internship was an APPIC member however, the supervisor's subsequent calculations indicated that Dr. Moreno's supervision hours do not meet the requirements of A.R.S. §32-2071(F). Additionally, the Committee noted that Dr. Moreno's references indicated that the dates of the relationship ended in 2006 which does not meet the requirement of R4-26-203(8)(b). It was the consensus of the Committee to request additional information regarding the deficiencies noted in her application.

MOTION: Dr. Meier moved to forward the applications of David Michael Stein, Ph.D., Dixie Jean Woolston, Ph.D., Jessica Ostendorf Pishney, Psy.D., Margot Scott Bradley, Psy.D., and Nicole C. Spanakis, Psy.D., to the Board for approval of licensure upon payment of the pro-rated license fee, to forward the application of Elizabeth Bacon, Ph.D. with recommendation of denial and to request additional information as noted above from Jessica Weeks, Ph.D., Lucinda Gray, Ph.D. and Traci Ryan Spriggs Moreno, Psy.D. Dr. Mellott seconded.

VOICE VOTE: The motion carried 2-0.

D. Requesting Approval of Postdoctoral Experience for Licensure

Committee members proceeded with a substantive review of the application.
