The Arizona Board of Psychologist Examiners is adopting the Enhanced EPPP* on November 1, 2020.

Who is Required to Take the Enhanced EPPP (Parts 1 & 2)?^a

If an initial application^b is received before November 1, 2020, if approved, the applicant will be authorized to sit for EPPP (Part 1 only). If an initial application^b is received on or after November 1, 2020, if approved, the applicant will be authorized to sit for the Enhanced EPPP (Parts 1 & 2).

In all cases, the initial application received date is the determining factor. Complete dates, approved dates, re-application received dates, etc. are not applicable in determining if an applicant is approved to sit for the EPPP (Part 1 only) or required to take the Enhanced EPPP (Parts 1 & 2).

An applicant has been approved by the Board to test prior to November 1, 2020, but the applicant has not yet taken the exam on or after November 1, 2020.	No
An applicant has been approved by the Board to test, does not take the exam prior to November 1, 2020, and requests a time frame extension on or after November 1, 2020.	No
An applicant has been approved by the Board to test, fails the exam, submits a re-application ^c before November 1, 2020, but the re-application has not yet been approved by the Board on or after November 1, 2020.	No
An applicant has been approved by the Board to test, fails the exam before November 1, 2020, but re-applies ^c to take the exam on or after November 1, 2020.	No
A temporary license holder whose temporary license application was received before November 1, 2020 and fails the exam; requests to re-take the exam on or after November 1, 2020.	No
The initial application ^b is received on November 1, 2020.	Yes
The initial application ^b is received after November 1, 2020.	Yes
An applicant has failed the exam 3 times. Applies anew ^d , on or after November 1, 2020, and is required to submit the initial application again and include a detailed, written study plan. Transcripts and verifications may be transferred from previous application to new initial application.	Yes
An initial application by Waiver is received on or after November 1, 2020, The applicant has passed the EPPP Part 1 under another state's authorization and the other state does not require EPPP Part 2 (Enhanced EPPP), and the applicant <u>is NOT licensed</u> in another state.	Yes
An initial application by Waiver is received on or after November 1, 2020, The applicant has passed the EPPP Part 1 under another state's authorization and the other state does not require EPPP Part 2 (Enhanced EPPP), and the applicant <u>is licensed</u> in another state.	No

^b. Initial Application: This is referencing the standard application, Psychologist Application for Exam and/or Licensure. Psychologists applying for licensure by Credential or Universal Recognition are excluded from this matrix.

^c. Re-Application: If an applicant does not pass the exam, an applicant may re-apply for approval to sit two additional times following an initial application. After three failed attempts, the applicant must apply anew by submitting the initial application.

^d. Apply Anew: A.A.C. R4-26-203.03(D) states all circumstances in which an individual must apply anew by submitting the initial application.
