1. CALL TO ORDER

3. CASE DISCUSSION/DECISION

a.) Connie Pyburn, Ph.D., RFI 10-19

The complainant was available by telephone and made a brief statement. The licensee was also available by telephone and addressed the Committee. Dr. Karp summarized the case, including salient points of the investigation and pertinent records. After deliberation, Dr. Karp made a motion, seconded by Dr. Bohanske to continue this investigation and to subpoena records from Dr. Pyburn. The motion carried (3-0).

b.) Shalene Kirkley, Ph.D., RFI 10-25

The complainant was available by telephone but made no statement. The licensee was present with her attorney, Charles Hover, III, but they did not wish to make a statement. Ms. Hunter-Williams summarized the case, including salient points of the investigation and pertinent records. After deliberation, the Committee members found no evidence of violation of statute or rule by the licensee. Dr. Karp made a motion, seconded by Dr. Bohanske, to dismiss the case. The motion carried (3-0).
