1. CALL TO ORDER

3. APPROVAL OF MINUTES

Minutes from the June 13, 2012 Complaint Screening Committee Meeting were considered for approval. Dr. Mellott abstained leaving no quorum to vote on the minutes. The minutes were tabled to be considered at a future meeting.

4. CASE DISCUSSION/DECISION

a) **Robin C. Ford., Ed.D. RFI 12-02**

Dr. Mellott summarized the case, including salient points of investigation and pertinent records. The Licensee and Licensee's legal counsel, Faren Akins, were present and answered Committee members' questions. The Complainant was present, requested to speak, made a statement and answered Committee member's question. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Mellott made a motion, seconded by Dr. Bohanske, to dismiss the case. The motion carried 2-0 on a roll call vote.

b) **Brent B. Geary, Ph.D., RFI 12-10**

Dr. Bohanske summarized the case, including salient points of investigation and pertinent records. The Licensee and Licensee's legal counsel, Larry Cohen, were present and answered Committee members' questions. The Complainant was not present. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Mellott made a motion, seconded by Dr. Bohanske, to dismiss the case. The motion carried 2-0 on a roll call vote.

c) **Vijay Jain, Ph.D., RFI 12-12**

Dr. Mellott stated that this case was referred by the Arizona Nursing Board. Dr. Mellott summarized the case, including salient points of investigation and pertinent records. The Licensee and Licensee's legal counsel, Faren Akins, were present and answered Committee members' questions. The Complainant was not present. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Mellott made a motion, seconded by Dr. Bohanske, to dismiss the case. d) **James C. Rau, Ph.D., 12-18**

Dr. Mellott summarized the case, including salient points of investigation and pertinent records. The Licensee and Licensee's legal counsel, Larry Cohen, were present and answered Committee members' questions. The Complainant was not present. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Mellott made a motion, seconded by Dr. Bohanske, to dismiss the case. e) **Albert K. Jordan, Psy.D., RFI 12-19**

Dr. Bohanske summarized the case, including salient points of investigation and pertinent records. The Licensee was present for the meeting in the audience but did not request to speak. The Complainant was not present. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Bohanske made a motion, seconded by Dr. Mellott, to dismiss the case. The motion carried 2-0 on a roll call vote.

There being no further business to come before the Committee, a motion to adjourn was made by Dr. Mellott, seconded by Dr. Bohanske, and unanimously carried 2-0. The meeting adjourned at 9:35 a.m.
