3. CASE DISCUSSION/DECISION

a) Anthony Luick., Ph.D. RFI 12-28

Dr. Mellott summarized the case, including salient points of investigation and pertinent records. The Complainant was present, requested to speak and made a statement. The Licensee and Licensee's legal counsel, Tom Slutes, were present. Dr. Luick requested to speak, made a

statement and answered Committee members' questions. Dr. Mellott made a motion, seconded by Mr. Larson to move RFI 12-28 to the full Board for possible violations of A.R.S. §32-2061(13)(g) Engaging or offering to engage as a psychologist in activities not congruent with the psychologist's professional education, training and experience; A.R.S. §32-2061(13)(o) providing services that are unnecessary or unsafe or otherwise engaging in activities as a psychologist that are unprofessional by current standards of practice; A.R.S. §32-2061(13)(dd) Violating an ethical standard adopted by the Board; specifically, American Psychological Association Ethical Principles of Psychologists and Code of Conduct 3.05 Multiple Relationships. The motion carried 2-0 on a roll call vote.

4. ADJOURN

There being no further business to come before the Committee, a motion to adjourn was made by Mr. Larson, seconded by Dr. Mellott, and unanimously carried 2-0. The meeting adjourned at 9:11 a.m.
