## 6. DISCUSSION, CONSIDERATION, AND POSSIBLE ACTION RELATING DR. ANTHONY LUICK'S PETITION FOR REHEARING FILED IN CASE NO. 13-F-1228-SYA

Dr. Brundage provided a summary to the Board and reviewed procedural matters. Dr. Luick was not present. Mr. Tom Slutes, attorney for Dr. Luick, was present, requested to speak and made a statement to the Board. The motion carried 6-0 on a roll call vote.

## 7. DISCUSSION, CONSIDERATION, AND POSSIBLE ACTION RELATING TO SELF REPORT MADE BY JONATHAN SHELTON, Psy.D. PURSUANT TO A.R.S. §32-3208

Ms. Martin provided a summary to the Board. Board members stated that Dr. Shelton reported his drug possession charge within the statutory time-frame and presented evidence that his case was dismissed.

Dr. Beljan joined the meeting at 8:09 a.m.

After deliberation, Dr. Wechsler made a motion, seconded by Dr. Bohankse, to take no action in this matter. The motion carried 5-0-1 with Dr. Beljan abstained.

# 8. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION REGARDING R. RUSS, PH.D. FAILURE TO DISCLOSE LICENSING/REGISTRATION HISTORY AND SUBSEQUENT SUBMISSION OF RELATED CORRESPONDENCE

Ms. Duracinski provided a summary to the Board. Dr. Russ was present telephonically, requested to speak, made a statement and answered Board members' questions. Dr. Russ stated that when he submitted his initial application for licensure he misunderstood and believed that he only needed to report to the Board relevant licenses/registrations that he holds. He acknowledged his oversight and has submitted information pertaining to each of his licenses/registrations that he holds in various professions and jurisdictions.

Board members expressed concern regarding Dr. Russ' failure to report his licenses/registrations. Board members stated that it is the applicant's responsibility to disclose this information on the application for licensure. Following deliberation, Mr. Donaldson made a motion, seconded by Dr. Bohanske, to take no action in this matter. The motion carried 6-1 with Dr. Wechsler voting no.

# 9. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION REGARDING APPLICATION FOR LICENSURE AS A PSYCHOLOGIST SUBMITTED BY JAMEE NICOLETTI, PH.D. AND POSSIBLE DENIAL OF THE SAME

Dr. Wechsler provided a summary to the Board. Board members proceeded with a substantive review of Dr. Nicoletti's application and subsequent submission. Upon review, the Board noted that the materials submitted were complete and fulfilled the requirements of statutes and rules.
