**1. CALL TO ORDER**

The regular session of the Arizona Board of Psychologist Examiners Complaint Screening Committee was called to order by Chairman Donaldson, at 10:00 a.m. on June 12, 2013. One executive session was held.

**3. CASE DISCUSSION/DECISION**

**a) David Davidson-Methot, Ph.D., RFI 12-40**

Mr. Donaldson summarized the case, including salient points of investigation and pertinent records. The Licensee was present, and represented by legal counsel, Larry Cohen. Mr. Cohen requested to speak and made a statement. Dr. Davidson-Methot answered Committee members' questions. After deliberation, the Committee members found no evidence of violation of statute

or rule by the Licensee. Dr. Brundage made a motion, seconded by Dr. Wechsler, to dismiss the case. The motion unanimously carried (3-0), by a voice vote.

**b) Nancy L. Mann, Psy.D., RFI 13-08**

Dr. Wechsler summarized the case, including salient points of investigation and pertinent records. The Licensee was present, and was not represented by legal counsel. Dr. Mann answered Committee members' questions. The Complainant D.M. was not present to answer Committee members' questions. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Brundage made a motion, seconded by Dr. Wechsler, to dismiss the case. The motion unanimously carried (3-0), by a voice vote.

**c) David Mark Anderson, Psy.D., RFI 13-03**

Dr. Brundage summarized the case, including salient points of investigation and pertinent records. The Licensee was not present, and was not represented by legal counsel. The Complainant R.K. was present telephonically to answer Committee members' questions. C.P., Complainant's ex-spouse was present telephonically and answered Committee members' questions. After deliberation, Dr. Wechsler made a motion, seconded by Dr. Brundage, and unanimously carried (3-0), by voice vote, to move into Executive Session, to obtain confidential legal advice from the Board's attorney. The Committee members went into Executive Session at 10:59 a.m. and resumed open session at 11:23 a.m.

Upon returning to open session, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Brundage made a motion to dismiss the case, seconded by Mr. Donaldson, to dismiss the case. The motion unanimously carried (3-0), by a voice vote.

**4. ADJOURN**

There being no further business to come before the Committee, a motion to adjourn was made by Dr. Brundage, seconded by Dr. Wechsler, and unanimously carried (3-0), by voice vote. The meeting adjourned at 11:32 a.m.
