**1. CALL TO ORDER**

The regular session of the Arizona Board of Psychologist Examiners Complaint Screening Committee was called to order by Chairman Donaldson, at 10:09 a.m. on July 12, 2013. One executive session was held.

**3. CASE DISCUSSION/DECISION**

a) **Juli Warzynski, RFI T-13-04 & RFI T-13-05**

Dr. Brundage summarized the case, including salient points of investigation and pertinent records. Complainants Dr. Laura Brookham and Dr. John Toma were present, requested to speak, and made statements. Dr. Brookham and Dr. Toma answered Committee members' questions. Ms. Warzynski was not present, but was represented by legal counsel, Carl Mariano and Bruce Smith. Mr. Mariano and Mr. Smith requested to speak, made statements, and answered Committee members' questions. After deliberation, Mr. Donaldson made a motion, seconded by Dr. Brundage, and unanimously carried (3-0), by voice vote, to move into Executive Session, to obtain confidential legal advice from the Board's attorney. The Committee members went into Executive Session at 10:49 a.m. and resumed open session at 10:57 a.m.

Upon returning to open session, the Committee members found no evidence of violation of statute or rule by Ms. Warzynski. Dr. Brundage made a motion, seconded by Dr. DiBacco, to dismiss both RFI T-13-04 & RFI T-13-05. The motion unanimously carried (3-0), by a voice vote.

Dr. DiBacco left the call at 11:15 a.m.

Dr. Wechsler joined the meeting at 11:22 a.m.

b) **Valarie Hannemann, Ph.D., RFI 13-02**

Dr. Wechsler summarized the case, including salient points of investigation and pertinent records. Complaint H.J. was present, requested to speak, and made a statement. The Licensee was present (telephonically), and represented by legal counsel (in person), Faren Akins. Dr. Hannemann requested to speak, made a statement, and answered Committee members' questions. Mr. Akins requested to speak and made a statement. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Wechsler made a motion, seconded by Mr. Donaldson, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

c) **Glenn Moe, Ph.D., RFI 13-11**

Mr. Donaldson summarized the case, including salient points of investigation and pertinent records. Complaint M.B. was present, requested to speak, and made a statement. The Licensee was present, and represented by legal counsel, Charles Strubble. Dr. Moe requested to speak, made a statement, and answered Committee members' questions. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Mr. Donaldson made a motion, seconded by Dr. Brundage, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

There being no further business to come before the Committee, a motion to adjourn was made by Mr. Donaldson, seconded by Dr. Brundage, and unanimously carried (3-0), by a voice vote. The meeting adjourned at 12:52 p.m.
