1. CALL TO ORDER

The regular session of the Arizona Board of Psychologist Examiners Complaint Screening Committee was called to order by Chairman Bohanske, at 8:30 a.m. on October 9, 2013.

3. CASE DISCUSSION/DECISION**a) John R. Stapert, Psy.D., RFI 13-15**

Dr. Bohanske summarized the case, including salient points of investigation and pertinent records. The Licensee was not present but was represented by legal counsel, Mr. Michael Wolver. Mr. Wolver requested to speak on behalf of his client, Dr. Stapert, and made a brief statement. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. Bohanske made a motion, seconded by Dr. DiBacco, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

b) Nadine C. Cole, Ph.D., RFI 13-19

Dr. DiBacco summarized the case, including salient points of investigation and pertinent records. The Licensee was present and represented by legal counsel, Mr. Faren Akins. Dr. Cole requested to speak, made a statement, and answered Committee members' questions. Mr. Akins requested to speak and made a statement. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Mr. Robichaud made a motion, seconded by Dr. DiBacco, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

c) Robin Dilley, Ph.D., RFI 13-21

Dr. DiBacco summarized the case, including salient points of investigation and pertinent records. The Licensee was present and represented by legal counsel, Mr. Christopher Rapp. Dr. Dilley requested to speak, made a statement, and answered Committee members' questions. Mr. Rapp requested to speak and made a statement. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Dr. DiBacco made a motion, seconded by Mr. Robichaud, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

d) Bryan Davey, Ph.D., BCBA, RFI BA-13-02

Mr. Robichaud summarized the case, including salient points of investigation and pertinent records. The Licensee was present and not represented by legal counsel. The Complainant was present and noted she would answer questions if necessary. Dr. Davey requested to speak, made a statement, and answered Committee members' questions. The Committee had no questions for the complainant. After deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Mr. Robichaud made a motion, seconded by Dr. DiBacco, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

e) Michael Belus, Psy.D., RFI 13-23

Dr. DiBacco made a motion to move into Executive Session to seek confidential legal advice from the Board's attorney. Motion carried unanimously (3-0), by voice vote. The Committee members went into Executive Session at 9:43 a.m. and resumed open session at 10:03 a.m.

Upon returning to open session, Dr. Bohanske summarized the case, including salient points of investigation and pertinent records. The Licensee was present and was not represented by legal counsel. Dr. Belus requested to speak, made a statement, and answered Committee members' questions. Following deliberation, the Committee members found no evidence of violation of statute or rule by the Licensee. Mr. Robichaud made a motion, seconded by Dr. DiBacco, to dismiss the case. The motion carried unanimously (3-0), by a voice vote.

4. ADJOURN

There being no further business to come before the Committee, a motion to adjourn was made by Dr. DiBacco, seconded by Mr. Robichaud, and unanimously carried (3-0), by a voice vote. The meeting adjourned at 11:35 a.m.
