3. DISCUSSION, CONSIDERATION, AND POSSIBLE ACTION REGARDING APPLICATION FOR LICENSURE AS A PSYCHOLOGIST SUBMITTED BY MARK PEUGEOT, PH.D.

Dr. Brundage provided a summary to the Board stating that Dr. Peugeot's application was reviewed at the April 29, 2014, Application Review Committee (Committee) meeting. Dr. Brundage explained that the Committee voted to issue a Request for Additional Information or Documentation letter to Dr. Peugeot pertaining to his core program requirements in ethics. Specifically, the Committee noted that Dr. Peugeot appeared deficient one quarter hour in his ethics requirement. Dr. Brundage stated that Dr. Peugeot's Program at the Uniformed Services University of the Health Sciences is accredited by the American Psychological Association therefore, additional information pertaining to his core program requirement in ethics is not necessary pursuant to statute.

Upon review of Dr. Peugeot's application the Board recognized that his doctorate program in Clinical Psychology at the Uniformed Services University of the Health Sciences meets the requirements for licensure pursuant to A.R.S. §32-2071.01(C) and that additional information regarding his core program in ethics is not necessary.

Upon further review of Dr. Peugeot's application, the Board noted a discrepancy in the number of internship hours he indicated he intends to use toward licensure versus the number of internship hours his Director of Training, Gregory Carron, Psy.D., indicated he received. At this time, the Board is requesting the number of hours Dr. Peugeot received during his internship. In addition, the Board noted the Supervised Preinternship Experience Verification form indicated the written training plan did not designate an allotment of time for each training activity with no explanation provided.

At this time, the Board is requesting that the Director of Clinical Training provide an explanation and submit it directly to the Board office. The Board noted that it would like the Application Review Committee to consider Dr. Peugeot's application at the June 3, 2014, Committee meeting.

Dr. DiBacco made a motion, seconded by Dr. Beljan, to issue a Request for Additional Information letter to Mark Peugeot, Ph.D. regarding the deficiencies discussed in his application. The motion carried 6-0.
