CONTINUING EDUCATION COMMITTEE REGULAR SESSION MINUTES

December 2, 2011 7:30 a.m. 1400 West Washington Room # 235 Phoenix, AZ 85007

1. CALL TO ORDER

The regular session of the Arizona State Board of Psychologist Examiners Continuing Education Committee (CEC) was called to order by Dr. Brundage at 7:30 a.m. No executive sessions were held.

3. REVIEW, DISCUSSION, AND POSSIBLE ACTION REGARDING THOSE AUDITEES RESPONSES TO CE DEFICIENCIES:

After discussion and deliberation, Dr. Mellott made a motion, seconded by Dr. DiBacco, to find the above noted licensees in compliance with the Board's 2009-2011 CE Audit. The motion carried (3-0). The Committee directed staff to notify these licensees, via a letter, that their compliance with the CE audit was met.

4. REVIEW, DISCUSSION, AND POSSIBLE ACTION REGARDING LICENSEES WHO FAILED TO SUBMIT THEIR AUDIT MATERIALS/LATE SUBMISSION

Oscar Hardin, Ph.D. – Ms. Hinckley provided a summary to the Board. After deliberation, it was noted that Dr. Hardin's CE submission was in compliance with A.A.C. R4-26-207. It was the consensus of the Committee to forward this matter to the full Board for review and clarification regarding Dr. Hardin's request to be placed on inactive status and for Dr. Hardin's failure to timely submit his CE materials.

<u>Larry Pristo, Ph.D.</u> – Committee members proceeded with a substantive review of Dr. Pristo's CE audit submissions. Upon review, the Committee noted Dr. Pristo did not submit an affidavit documenting his self-study for Category II nor for his work in the school district. The Committee directed Board staff to send a letter to Dr. Pristo requesting that he submit an affidavit for his self-study and for his work in the school district. The Committee noted that upon receipt of the signed affidavit Dr. Pristo will have met the CE requirements pertaining to A.A.C. R4-26-207. After deliberation, it was the consensus of the Committee to forward this matter to the full Board for review for Dr. Pristo's failure to timely submit his CE materials.

Luz Mogrovejo, Ph.D. - Ms. Hinckley provided a summary to the Board clarifying that the Committee granted Dr. Mogrovejo an extension to submit her CE materials therefore Dr. Mogrovejo's submission was received timely. Committee members proceeded with a substantive review of Dr. Mogrovejo's CE audit submissions. Upon review, the Committee noted that Dr. Mogrovejo presented a course entitled Are Mood Disorders Over Diagnosed or Under Diagnosed? Dr. Mogrovejo applied three hours of credit for her presentation. The Committee noted that pursuant to A.A.C. R4-26-207(E) "A licensee who organizes and presents a continuing education activity receives the same number and category of continuing education hours described in subsection (C) as those persons attending the continuing education activity." The Committee noted that the presentation was one hour, therefore, at this time the Committee can only accept one hour for Dr. Mogrovejo's presentation toward her Category I requirements. The Committee noted that Dr. Mogrovejo attended courses entitled Workplace Professionalism, Violence in the Workplace-Warning Signs, Intensive Short-Term Dynamic Psychotherapy, Suicide Prevention Procedures and Overview of Rating Scales, Rating for Clinical Trials, Concomitant Medications and Treatments, Recruitment & Prescreening. The Committee noted that Dr. Mogrovejo failed to provide proof of attendance or a certificate of completion for the above mentioned courses. The Committee noted that Dr. Mogrovejo attended a course entitled Abbott M06-876 Trial (Interactive Videos/Tests Training) which does not fulfill the Category II continuing education as it does not pertain to "enhancement of psychological practice, education, or administration" pursuant to A.A.C. R4-26-207(C)(2). Additionally, the Committee noted that Dr. Mogrovejo attended courses entitled NCCHC Standards Relative to Mental Health Care in the Jails-Best Medication Practices-Peer Review & Building Bridges of Support for Grieving Children. The Committee noted that the above mentioned courses may not fulfill the requirements of A.A.C. R4-26-207(D). The Committee requested that Dr. Mogrovejo submit further information and documentation regarding the CE providers for the above noted courses to determine whether the providers fulfill the requirements of A.A.C. R4-26-207(D) and to provide proof of attendance or a certificate of completion for the above noted courses. It was the consensus of the Committee to review additional submissions from Dr. Mogrovejo at a future meeting.

<u>David Prince</u>, <u>Psy.D.</u> – Committee members proceeded with a substantive review of Dr. Prince's CE audit submissions. Committee members noted that Dr. Prince's CE documentation was complete and meets the

CE requirements pertaining to A.A.C. R4-26-207. It was the consensus of the Committee to move this matter to the full Board for review for Dr. Prince's failure to timely submit his CE materials.

After discussion and deliberation, Dr. Mellott made a motion, seconded by Dr. DiBacco, to move Oscar Hardin, Ph.D., Larry Pristo, Ph.D. and David Prince, Psy.D. to the full Board for review for failure to timely submit their CE materials. The motion carried (3-0).

5. NEWBUSINESS/AGENDA ITEMS FOR FURTURE MEETINGS

It was the consensus of the Committee to direct Board staff to send Dr. Mogrovejo a letter regarding the above noted deficiencies and to review additional submissions at a future meeting.

6. ADJOURN

There being no further business to come before the Continuing Education Committee, a motion was made by Dr. DiBacco, seconded by Dr. Brundage, and unanimously carried (3-0), to adjourn the meeting at 8:54 a.m.
